I. Scope of Services

The U.S. Embassy – Guatemala requires the purchase of seven (7) sea containers as follows: Six (6) 20 foot, containers for sleeping quarters space at a temporary location in Tilapa, San Marcos; one (1) 20-foot sea container for administrative office space in Tilapa, San Marcos.

This shall be a firm-fixed price type of purchase order.

The price listed below shall include all labor, materials, overhead, profit, and transportation necessary to deliver the required items to deliver the required items to Tilapa, San Marcos Department.

II. Pricing

2.1 VALUE ADDED TAX

Value added tax (VAT) shall not be included in the CLIN rates. It should be priced as a separate line item in the proposal. The amount of tax to be charged is 12% (IVA). The Government is exempt from taxes (IVA tax). Once invoiced, awarded vendor will be provided with a tax exemption form as VAT payment. The portions of the solicitation subject to VAT are:

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I. The purpose of this firm fixed price purchase order is to acquire Seven (7) sea or prefabricated containers: Six will be used as sleeping quarters. one as office space.

*** For the sleeping quarters:**

Six (6) 20 feet, containers will be used for sleeping quarters space in Tilapa San Marcos. Containers can be prefabricated if access to location is easier.

To maximize space, 2 containers will be placed together without the division. In total, the Project requires 3 modules for sleeping quarters formed with 6 containers.

1. Containers must be leveled (0 degrees) at placement surface, elevated 12 inches with "on site" removable fabricated concrete stands.
2. Containers must be affixed together in all meeting points, utilizing twist locks. Internal floors cannot have gaps and must be leveled, walls and roofs unions must be watertight, and no sharp edges are accepted.
3. Original container doors will not be utilized but need to remain in working order.

* Watertight, windproof, no visible corrosion in extent of over 5% of the surface (before paintjob), limited to nonstructural damage on floor, walls, roof, and doors (dents are acceptable within 5 inches of dent extent and 1/2 inch deep), odor free from any chemicals, mold or mildew, no visible presence of mold or mildew.

Specifications include:

- A. Dry wall on internal ceiling and walls
- B. Thermal insulation: Internal ceiling and walls insulation (thermal, sound, fire, nontoxic) and drywall installation on internal ceiling and walls
- C. Interior paint: white color, water based, for interior use, flat, washable. Resistant to hot weather temperatures and saline environment
- D. Rubber floor: Container floor must be leveled; black anti slip vinyl installed
- E. A/C Unit (24,000BTU for the 2-container barracks): to be installed on ceiling with required power outlet. If vendor determines power is not sufficient for AC unit, other ventilation systems can be considered (such as air extractors). To be installed at opposite end of the entry point. Wiring and piping should be external as well as condensation drainage to the outside of the container
- F. Two (2) sliding windows with screens: White PVC ventilation windows, watertight, with mosquito nets. Must be no see through but translucent. 60 inches wide x 15 inches high, 6ft from the floor
- G. The following electrical installation is required: Install 2 ceiling lamps in center of each container to adequately illuminate them (2 per barracks): T8 led tube light, 4 ft. 1800 to 2000 lumens white light (with protection covers) light switch to be installed towards the side door access by the circuit breaker box, 48 inches from the floor, 5 inches from the main access door
- H. Install number (1) outlet sockets (2 plug) on each wall of each container. When containers are placed without the division it should be 2 outlets per wall. *All electrical wiring and piping should be external
- I. No plumbing work is required

- J. Exterior of the container: Painted Gray, exterior walls and ceiling, using synthetic automotive paint and/or oil finish. Apply one coat of anticorrosive material, followed by one coat of synthetic automotive painting and 2 coats of paint (anticorrosive, all-weather condition for external use)
- K. Steps to facilitate access to container: Fabrication of access steps/stairs, metallic, painted with same color as containers, corrosion preventive, diamond tread steel platforms 1/8-inch thick, anti-slide. Minimum weight capacity of 300 lbs.
- L. Overall width 42 inches, overall height 15 inches, top platform 36 inches deep, middle step 10 inches deep. Fabricated with galvanized steel angle 1 1/2 inches x 3/16 inch. Containers will be placed on top of 12-inch height concrete stands
- M. Over Door Rain Gutter: Made with container cutouts, to extend 14 Inches from container wall with a length of 48 inches on top of door frame
- N. Side door for accessing the sleeping quarters. Wood or metallic as per vendor suggestions due to weather conditions on the area
- O. Cleaning of the area is required: removal of bushes, trees that impede the placement of the containers. Site leveling might be required as well
- P. Containers shall be placed over concrete pillars: concrete stands Containers must be leveled (0 degrees) at placement surface. There will be a minimum of 6 ea. concrete pillars per 20 ft container, 4 ea. placed at the corners and 2 ea. placed midway down the container

*** Office space**

One (1) 20FT, Standard, with Internal Insulation and Drywall. A/C unit will be required. If energy is not sufficient for installing AC units, alternate methods of ventilations can be accepted with previous discussion. Container will have windows with mosquito nets, power outlets, lighting and vinyl floors. Containers will be painted with adequate materials for saline weather.

* Watertight, windproof, no visible corrosion in extent of over 5% of the surface (before paintjob), limited to nonstructural damage on floor, walls, roof and doors (dents are acceptable within 5 inches of dent extent and 1/2 inch deep), odor free from any chemicals, mold or mildew, no visible presence of mold or mildew. Prior to selection of vendor, a site visit to offerors will take place to ensure this requirement.

Specifications include:

- A. Interior paint adequate for saline weather
- B. Rubber floor: Container floor must be leveled; black anti slip vinyl installed
- C. One (1) air conditioner unit 18,000BTU or other ventilation systems if power is not sufficient. To be installed at opposite end of the entry point. Wiring and piping should be external as well as condensation drainage to the outside of the container.
- D. Thermal insulation: Internal ceiling and walls insulation (thermal, sound, fire, non-toxic) and drywall installation on internal ceiling and walls.
- E. Exterior paint type: oil
- F. Exterior Paint color: gray
- G. Coats of paint (interior & exterior): 2
- H. Lighting (interior) 4 LED strips: T8 led tube light, 4 ft. 1800 to 2000 lumens white light (with protection covers) light switch to be installed towards the side door access by the circuit breaker box, 48 inches from the floor, 5 inches from the main access door
- I. Electrical Outlets – Four 2-plug interior outlets. *All electrical wiring and piping should be external

- J. Steps – to facilitate access to container: Fabrication of access steps/stairs, metallic, painted with same color as containers, corrosion preventive, diamond tread steel platforms 1/8-inch thick, anti-slide. Minimum weight capacity of 300 lbs.
- K. Overall width 42 inches, overall height 15 inches, top platform 36 inches deep, middle step 10 inches deep. Fabricated with galvanized steel angle 1 1/2 inches x 3/16 inch. Containers will be placed on top of 12-inch height concrete stands
- L. Metal bar door with lock
- M. Metal entrance door: 78 inches height, 36 inches wide, painted (same color as container), located on the left side wall towards the container doors 12 inches from the front
- N. Over Door Rain Gutter: Made with container cutouts, to extend 14 Inches from container wall with a length of 48 inches on top of door frame
- O. Door lock Horizontal opening handle outside, push bar opening from the inside (emergency exit locking system) with key lock, 2 sets of keys to be included. Lock must be accessible from inside and outside when unlocked
- P. Containers shall be placed over concrete pillars: concrete stands Containers must be leveled (0 degrees) at placement surface, elevated 12 inches with "on site" removable fabricated concrete stands





II. Delivery Location and Time

A. The Contractor shall deliver all ordered items to Tilapa, San Marcos.

B. The Contractor shall deliver all items not later **30** days after date of contract award.

C. Any Contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice of at least 5 days will be required.

D. Site Visit:

A pre-proposal meeting will be scheduled and notified to interested offerors. In order to participate in the site visit you are required to submit an email to Ingrid Cifuentes at CifuentesIG@state.gov not later than December 27, 2021 by 17:00 hours with the name of the company, full name and DPI number of attendees.

The site visit has been scheduled for January 11, 2022 at 9:00 AM. Additional information will be provided at a later time.

The purpose of this meeting will be to address any questions you may have and for offerors to be able to see the access, mobility and equipment to be used for the delivery and placement of the containers, especially space to have containers and tools to work on site. If there is requirement for electricity or special needs to perform this project, vendor shall be self-sustainable to perform the required work on site.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible website(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)

(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) *Representation*. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).

(v) *Covered Telecommunications Equipment or Services-Representation*. Section 889(a)(1)(A) and section 889 (a)(1)(B) of Public Law 115-232.

(1) The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services".

(2) The Offeror represents that—

(i) It does, does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(ii) After conducting a reasonable inquiry for purposes of this representation, that it does, does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

(End of Provision)

Add the following provision:

52.229-11 Tax on Certain Foreign Procurements—Notice and Representation (JUN 2020)

(a) *Definitions*. As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or

services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701 (a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates "is" in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects "is" in paragraph (d)(1) and "partial or no exemption" in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations.
