I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price indefinite delivery/indefinite quantity contract is to for the health and life insurance for our National Police Force assigned to the US Embassy – Guatemala by the local government in support to the USG Mission and in accordance with Attachment A.
- B. The contract will be for a one-year period from the date of the contract award, with one option year to extend services.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

I. Scope of Work

The purpose of this firm fixed indefinite delivery/indefinite quantity contract is to obtain health and life insurance services for the PNC agents force assigned to the U.S. Embassy – Guatemala by the local government and in accordance with the Memorandum of Agreement between the U.S. Embassy – Guatemala and the National Civil Police of Guatemala.

The Government of Guatemala recognizes its obligations under the Vienna Convention on Diplomatic Relations of 1961 to protect diplomatic missions. In addition to satisfying its obligations under the VCDR, the GD will provide a security presence, coverage, and response capability.

In virtue of the fact that the agents of the National Civil Police assigned to the U.S. Embassy – Guatemala are public servants of the State of Guatemala, the U.S. Embassy – Guatemala agrees to provide health and life insurance as part of the benefits of being a PNC who is assigned to the U.S. Embassy's PNC unit.

All PNC officers who have been assigned by the Guatemalan Government to the U.S. Embassy PNC Unit will receive supplemental health insurance. The insurance coverage shall also include any medications prescribed by a physician.

The service required is for health and life insurance for active National Police guards providing service at the United States Embassy in Guatemala City, Guatemala.

Coverage, included in this firm fixed price contract, must be in the country of Guatemala and it shall not include any dependents.

Medical expenses shall be covered at a 100% by the insurance policy at the time of service (no deductible will be paid when claims take place in the country).

Insurance shall include full medical coverage, medicines, and life insurance. The health and life insurance shall cover:

**Hospitalization.** 100% coverage at time of service. Maximum coverage of hospital room shall be Q1,000.00 daily. 100% coverage at time of service of in-patient hospital medical expenses including laboratory tests and x-rays, operating room costs, intensive care, prescription medicines and physical therapy. 100% coverage of out-patient services.

**Emergency Room.** 100% coverage of emergency room services.

**Professional Services and Treatment.** 100% coverage of doctors' and surgeons' fees incurred while hospitalized, at a hospital on an out-patient basis, at a clinic or doctor's office. 100% coverage of laboratory tests and x-rays.

**Prescription Drugs and Medicines.** 70% coverage of the cost of medicines and drugs for which a prescription is legally required. 90% coverage applies for generic medicine. Expenses incurred for medicines, vitamins, cold remedies, etc., that are available over the counter without a prescription will not be reimbursed even if prescribed by a physician. A 30% co-pay for brand

name medicine or a 10% co-pay for generic medicine on network drugstores will be required by the PNC Agent. Maximum coverage per calendar year is Q6,000.00 per person.

**Psychiatric Treatment.** Maximum coverage Q3,000.00 for external or internal Psychiatrist.

**Maximum Annual Coverage.** The insurance company will cover a maximum of insurance of Q400,000.00 per person per lifetime of the contract.

**Health Benefits Conditions and Limitations.**

There is no coverage for hearing; optical; orthodontia; elective cosmetic surgery; spa cures; rejuvenation cures; massage; exercise therapy; long term rehabilitative therapy; eyeglass frames; non-medical hospital charges such as telephones or television; home help, family help, or similar household assistance; fees of persons who are not licensed physicians or nurses; or services or supplies which have not been prescribed or approved by a physician or nurse.

The contractor will cover medical expenses incurred, subject to the stated limits. Payment will be made for reasonable and customary expenses of covered benefits. The medical treatment must be prescribed or provided by a physician or nurse licensed in Guatemala or in the country in which the treatment is received.

The Contractor shall ensure that health care under this contract does not exclude HIV/AIDS care up to a maximum of Q50,000.00 per lifetime of the contract. 100% coverage for medications to suppress opportunistic infections, such as tuberculosis and toxoplasmosis for employees who have HIV/AIDS.

It is required that a doctor or a clinic be assigned to the group for initial evaluation of the patient prior to be seen or referred to a specialist.

**Life Insurance.** The amount of life insurance coverage for each employee is of Q25,000.00 in the event the employee dies of natural or accidental causes. Conditions and limitations on the entitlement to life insurance benefits under this contract are as follows:

No benefits shall be payable if an employee's death or other insurance event was caused directly or indirectly by war. War shall be defined as declared or non-declared war or any martial operations or invasion, hostile acts of foreign powers, rebellion, riot, civil war, uprising, mutiny, operations by military or usurpatory authorities, martial law or state of siege or any other similar event or reason for declaring martial law or war. A terrorist attack shall not be considered war. No benefit shall be payable under this contract if the employee's bodily injuries have been caused directly or indirectly and totally or partially by:

1. Self-inflicted wounds or wounds inflicted at the employee's request, irrespective of the employee being sane or insane, including a suicide;
2. Violating the law or in resisting detention or arrest;
3. Participation in competitions involving the use of wheeled vehicles, horses, boats or water skis;
4. An accident resulting from the employee being under the influence of alcohol, drugs or other toxic substance unless administered by a physician.

Death as a result of a disease or physical or mental infirmities and medical or surgical treatment thereof (except pyogenic infection due to an accidental cut or wound) shall be considered a natural and not an accidental death.

Termination age for coverage is 75 years of age. Deductible per calendar year shall be Q0.00.

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) This clause applies only to foreign persons. It implements [26 U.S.C. 5000C](#) and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c)

(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. - (d) Orders may be issued by methods other than those enumerated in this clause only if authorized in the contract. (End of clause)

52.216-19 ORDER LIMITATIONS (OCT 1995)

(a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than \$10,000.00, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) Maximum order. The Contractor is not obligated to honor--

- (1) Any order for a single item in excess of than \$250,000.00;

Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

*Inverted domestic corporation*, means a foreign incorporated entity that meets the definition of an inverted domestic corporation under [6 U.S.C. 395\(b\)](#), applied in accordance with the rules and definitions of [6 U.S.C. 395\(c\)](#).

*Manufactured end product* means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern*—

## 52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or

services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701 (a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It  is  is not a foreign person; and

(2) If the Offeror indicates "is" in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14  a full exemption, or  partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects "is" in paragraph (d)(1) and "partial or no exemption" in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts.
