I. Scope of Services

- A. The Embassy of the United States in Guatemala requires to purchase a wideband HF collection system for a Radio Room. This system should be a Commercial-Off-The-Shelf (COTS) Signals Intelligence (SIGINT) system.
- B. The prices listed below shall include all labor, materials and all costs related to the wideband HF collection system, shipping, transportation, delivery, maintenance (if applicable) and installation of specified equipment and related materials.
- C. This is a firm-fixed price type of purchase order.
- D. All prices shall be provided in Quetzales.
- E. Valued added tax (VAT) shall not be included in the CLIN rates. It should be priced as a separate line item in the proposal. The amount of tax to be charged is 12% (IVA). The Government is exempt from taxes (IVA tax). Once invoiced, awarded vendor will be provided with a tax exemption form as VAT payment.

- I. The Commercial-Off-the-Shelf (COTS) Signals Intelligence (SIGINT) System with radio/receiver HF range, from 300 Hz to 29.999 Mhz shall be capable of collecting information in the frequencies included in this range. Software to manage the equipment must be included.

The equipment will be connected to a desktop computer; the computers will be connected to the internet system (see the diagram below). Full details must be included in the offer as well as an activity bar chart to confirm compliance of the requirement and dates.



Description:

The Commercial-Off-the-Shelf (COTS) Signals Intelligence (SIGINT) System with radio/receiver HF range should have the following features as a minimum:

1. Support for processing very wide SDR bandwidths (over 20 MHz)
2. Deliver a unique way to efficiently quantify and qualify a mission target environment, isolate targets of interest, and analyse their schedule, activity, behaviour, signalling mode and frequency usage patterns. It should aid collection managers in wisely using collection assets and help the traffic analyst better support collection operations.
3. Provide identical user-controlled functionality whether employed in real time ("live intercept") or non-real time ("playback of previously recorded digital wideband") operation.
4. Capable of ultra-low communications bandwidth, high resolution remote SDR service with up to 4 simultaneous remote radio operators.
5. Utilize a high-performance audio streaming codec for remote SDR operation and suitable for interactive real-time applications over commercial Internet.
6. Provide at least 6 virtual "drop" receivers.
7. Capability to set both wideband bandwidth for recording and span of visualization within that bandwidth.
8. Provide a "scroll" function to allow the user to continually search across the bandwidth being recorded without corrupting the recording.
9. Analysis capability allowing the analyst to rapidly scroll through hours of wideband recordings, annotate, and play back narrowband recordings.

10. Wideband file editing capability to allow the operator to remove unwanted portions of wideband recordings to conserve memory space.

Training

- An onsite training in Guatemala at the Monitoring Unit Facilities in Spanish for five (5) operator/technicians for five (5) days to take place in Guatemala at the Monitoring Unit facilities.
- Training should include classroom reading material and demonstrations. Student lab time with coaching.
- Training materials should be included preferably in Spanish (handouts, classroom graphics, copies of Operator Manual for the components of the software suite and any other relevant documents).

## II. Delivery Location and Time

- A. Vendor must be able to have the Commercial-Off-the-Shelf (COTS) Signals Intelligence (SIGINT) System with radio/receiver installed within three (3) weeks after receipt of the award.
- B. Place of performance: Office located at Puerto de San Jose, Escuintla. Physical address will be provided upon award. Delivery must be coordinated in advance.
- C. Schedule: Regular working hours are Monday through Thursday from 8:30 am to 4:00 pm and Friday 8:30 am to 12:00 pm.
- D. Any Contractor personnel involved with the delivery of the items shall comply with Standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made.
- E. Periods of Performance  
The base period of this purchase order starts on date of award and continues for twelve months, with four options to renew the support services.

F. Delivery information for Overseas vendors:

- Vendors outside Guatemala must consider taxes and delivery expenses when providing a quote (Incoterms DDP).
- U.S. Government will not provide customs clearance for the awarded vendor.
- All pricing must include delivery and installation to site.

a. Delivery date:

**\*Please note:**

Since this order is intended for an overseas destination, please make sure that all wood packaging material and palletizing material used must conform the standards in the International Standards for Phytosanitary Measures Publication No.15: "Guidelines for Regulating Wood Packaging Material in International Trade" (ISPM 15) and have the appropriate domestic delivery address. Shipments that do not meet these standards will be rejected and must be corrected at the contractor's expense.

The MSDS – material safe data sheet might be required for shipment, so please attach it to the shipment and send by e-mail.

In Addition, after the AWB, Commercial Invoice and Packing List are cleared; documentation will be used to initiate customs duties and tax exemption process in Guatemala, which usually takes three to four (3-4) weeks. This process can be submitted in advance before departure of the shipment to save time and avoid unnecessary warehouse and other related charges.

### III. Warranty

- Five-year warranty is requested to cover any defects in structure and its components.
- All warranty should be performed in Guatemala.
- Operation and maintenance manual in English and Spanish (if available).

- Technical assistance support must be provided 24/7 by Spanish speaking personnel.
- Maintenance shall be performed according to manufacturer recommendations and provided in Guatemala.
- Vendor shall guarantee and attach specifications proving that equipment meet the published specifications.
- Vendor shall replace any defective part with a part of equivalent of superior quality without any additional cost which may develop therein during a period of one (1) years from the date of the acceptance of the equipment by the Government. For this purpose, awarded vendor shall pay for all shipping charges.
- The Vendor shall warrants that the product, materials and services performed and described in this SOW should be free and clear of any defects in workmanship or materials.

IV. Vendor requirements

- Vendor shall deliver the items to prevent loss and misdirection.
- Should provide materials, equipment, transportation, labor, supervision in the programming of the radios.
- Vendor shall be aware that complete installation and proof of functioning is required by certified personnel.
- Shall comply with general safety rules and protective equipment for workers while programming.
- Shall examine all accompanying specifications included in this request to make sure that all requirements are thoroughly understood. In case where, in his opinion, there are omissions and/or errors in any of these documents, he shall inform immediately before the closing date of the proposal's submission.

V. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. (ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) This clause applies only to foreign persons. It implements 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c)(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. The Contractor should revise each IRS Form W-14 submission to reflect the exemption (if any) that applies to that particular invoice, such as a different exemption applying. In the absence of a completed IRS Form W-14 accompanying a payment request, the default withholding percentage is 2 percent for the section 5000C withholding for that payment request. (2) If the Contractor is a foreign person and has indicated in its offer in the provision 52.229-11, Tax on Certain Foreign Procurements—Notice and Representation, that it is fully exempt from the withholding, and certified the full exemption on the IRS Form W-14, and if that full exemption no longer applies due to a change in circumstances during the performance of the contract that causes the Contractor to become subject to the withholding for the 2 percent excise tax then the Contractor shall—

(i) Notify the Contracting Officer within 30 days of a change in circumstances that causes the Contractor to be subject to the excise tax withholding under 26 U.S.C. 5000C; and

(b) When New Year's Day, Independence Day, Veterans Day or Christmas Day falls on a Sunday, the following Monday is observed; if it falls on Saturday the preceding Friday is observed. Observance of such days by Government personnel shall not be cause for additional period of performance or entitlement to compensation except as set forth in the contract. If the contractor's personnel work on a holiday, no form of holiday or other premium compensation will be reimbursed either as a direct or indirect cost, unless authorized pursuant to an overtime clause elsewhere in this contract.

(c) When the Department of State grants administrative leave to its Government employees, assigned contractor personnel in Government facilities shall also be dismissed. However, the contractor agrees to continue to provide sufficient personnel to perform round-the-clock requirements of critical tasks already in operation or scheduled, and shall be guided by the instructions issued by the contracting officer or his/her duly authorized representative.

(d) For fixed-price contracts, if services are not required or provided because the building is closed due to inclement weather, unanticipated holidays declared by the President, failure of Congress to appropriate funds, or similar reasons, deductions will be computed as follows:

- (1) The deduction rate in dollars per day will be equal to the per month contract price divided by 21 days per month.
- (2) The deduction rate in dollars per day will be multiplied by the number of days services are not required or provided.

- (2) For the purpose of public safety, security of Government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities);
- (3) Telecommunications or video surveillance services provided by such entities or using such equipment; or
- (4) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.

*Critical technology* means—

- (1) Defense articles or defense services included on the United States Munitions List set forth in the International Traffic in Arms Regulations under subchapter M of chapter I of title 22, Code of Federal Regulations;
- (2) Items included on the Commerce Control List set forth in Supplement No. 1 to part 774 of the Export Administration Regulations under subchapter C of chapter VII of title 15, Code of Federal Regulations, and controlled-
  - (i) Pursuant to multilateral regimes, including for reasons relating to national security, chemical and biological weapons proliferation, nuclear nonproliferation, or missile technology; or
  - (ii) For reasons relating to regional stability or surreptitious listening;
- (3) Specially designed and prepared nuclear equipment, parts and components, materials, software, and technology covered by part 810 of title 10, Code of Federal Regulations (relating to assistance to foreign atomic energy activities);
- (4) Nuclear facilities, equipment, and material covered by part 110 of title 10, Code of Federal Regulations (relating to export and import of nuclear equipment and material);
- (5) Select agents and toxins covered by part 331 of title 7, Code of Federal Regulations, part 121 of title 9 of such Code, or part 73 of title 42 of such Code; or
- (6) Emerging and foundational technologies controlled pursuant to section 1758 of the Export Control Reform Act of 2018 (50 U.S.C. 4817).

*Interconnection arrangements* means arrangements governing the physical connection of two or more networks to allow the use of another's network to hand off traffic where it is ultimately delivered (e.g., connection of a customer of telephone provider A to a customer of telephone company B) or sharing data and other information resources.

*Reasonable inquiry* means an inquiry designed to uncover any information in the entity's possession about the identity of the producer or provider of covered telecommunications equipment or services used by the entity that excludes the need to include an internal or third-party audit.

*Roaming* means cellular communications services (e.g., voice, video, data) received from a visited network when unable to connect to the facilities of the home network either because signal coverage is too weak or because traffic is too high.

*Substantial or essential component* means any component necessary for the proper function or performance of a piece of equipment, system, or service.

(ii) Within 10 business days of submitting the information in paragraph (d)(2)(i) of this clause: any further available information about mitigation actions undertaken or recommended. In addition, the Contractor shall describe the efforts it undertook to prevent use or submission of covered telecommunications equipment or services, and any additional efforts that will be incorporated to prevent future use or submission of covered telecommunications equipment or services.

(e) *Subcontracts*. The Contractor shall insert the substance of this clause, including this paragraph (e) and excluding paragraph (b)(2), in all subcontracts and other contractual instruments, including subcontracts for the acquisition of commercial items.

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international

procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701 (a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C.

701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—
